MINUTES

The minutes of the meeting held on 14 July 2011 as circulated, were agreed and signed by the Chairman.

MATTERS ARISING

(a) Dog bin in Youlton – HDC have gone out to tender and will supply a new bin when supplies HD are restored, cost in the region of £250.

(b) Grit bin in Youlton – HD awaiting delivery of a green bin. HD

(c) Aldwark notice board - CS in the process of obtaining a quote from John Gandy; NK suggested also contacting Peter Pennock, who had recently made other local notice boards, for a quote. It was agreed that one side of the board should be lockable if possible, for PC notices.

PUBLIC CONTRIBUTIONS

Jenny & Pete Rudd raised the issue of ongoing discussions regarding work needed to the trees on Flawith village green and the subject was explored at length with RC stating that no decisions had as yet been made on any work to be carried out and the PC had merely obtained advice from two separate tree experts. It was agreed that some work was necessary as the area had become very overgrown and RC undertook to circulate a letter to Flawith residents setting out the recommendations of the tree experts, asking for opinions on the proposals. The matter would then be discussed further at the next PC meeting. Jenny Rudd expressed interest in becoming an active member of the Parish Group.

PARISH PLAN

Leisure: Play Area - safety matting is now in place and a new litter bin had been placed immediately outside the play area which would be emptied by HDC on a regular basis, negating the need for the small bin inside the gate.

Environmental: RC to contact Mike Riby regarding the current noxious smell around Flawith. RCRoads & grass verges: Hagg Lane, Youlton - grass not yet been cut and potholes need repairing HD/AB again. HD to speak to AB to see where things stand.

PARISH WEBSITE

CS had contacted Tollerton PC and was in discussion looking at ways of using the general information contained on the Tollerton website to avoid duplicating things on the Aldwark site, subject to agreement by Tollerton PC. RC to email Gudrun at Alne to try and establish a link between the 3 village sites. It was agreed to include a feature on the website in the next PC newsletter (www.aldwarkparish.co.uk) to encourage more people to make use of it.

HD was planning to hold a meeting in the near future to review the self help work carried out in the villages and plan for the future. He was asked to report back to the next PC meeting with suggestions for costed projects.
