**15/16 MINUTES**

The minutes of the meeting held on 20 January 2015 were agreed and signed as a correct record. There were no matters arising.

**15/17 PUBLIC FORUM**

The Chairman/Clerk handed out information on the forthcoming election and members were pleased to hear that there were several people who had expressed interest in joining the Parish Council.

Thanks were expressed to Henry Dean, Roland Crooke and Alan Boddy for their years of service to the community.

**15/18 CHAIRMAN/CLERK'S REPORT**

CS had attended a recent election briefing and talk on the election process held in Easingwold.

It was agreed that the current arrangement with councillors acting as Clerk and RFO in a voluntary capacity, with support from other councillors, had been very satisfactory and would be recommended to the incoming council in May.

**15/19 HDC PLANNING APPLICATIONS/DECISIONS**

None had been received since the last meeting.

**15/20 GRASS CUTTING**

No further information had been received from NYCC since the last meeting. It was agreed that Geoff Hancock be asked to continue to maintain the play area in Aldwark and reflect the cost of his public liability insurance in his charges, but to wait and see what work is carried out by NYCC to other areas of public interest in the village. It is hoped that residents will keep areas tidy adjacent to their own properties, as requested in the newsletter. Agreed to review at the next meeting.

**15/21 SUPERFAST BROADBAND**

Since the last meeting information had been received that British Telecom will almost certainly be bringing superfast broadband to the parish in phase 2 of their operation. In view of this, and following discussion with LN Communications about the likely low take up in Flawith which did not therefore render it a viable proposition, LN had decided not to proceed with their installation and CS was asked to request the return of the HDC grant for the additional repeater.

**15/22 MAY ELECTIONS**

Discussed in public forum. Councillors were given statutory notices to place on village notice boards.

**15/23 CLERK AND RESPONSIBLE FINANCE OFFICER**

It was agreed that CS should continue to act as the Council's Clerk and HD continue as the responsible Finance Officer until new appointments are made after the May elections. It was noted that Alison Pollock was willing to carry out an independent examination of the accounts.
