16/101 MINUTES OF THE MEETING HELD ON 9TH MAY 2017

The minutes were approved and signed by the Chair.

16/102 MATTERS ARISING FROM THE MINUTES, NOT ON THE AGENDA

16/103 APPLICATION TO TRANSPARENCY FUND

A grant of £543.18 had been awarded by the DCLG towards the purchase of a laptop, printer and software totalling £769.14+VAT The equipment had been added to the Zurich Insurance policy for no additional charge this year.

16/104 MINERALS AND WASTE JOINT PLAN

- a) Councillors wished to make no response to this consultation.
- b) Councillors were encouraged to respond to HDC's consultation on Hazardous Household Waste, details of which had been circulated.

16/105 GRASS-CUTTING

- a) The Chair reported that he had placed 2 licences on 2 green bins in the Play Area. This was so far proving to be sufficient. The Chair had met with Mr Hancock to discuss the frequency of grass and hedge-cutting in the play area.
- b) It was noted that certain roadside verges were overgrown and authority was delegated to Cllr Boddy to ask Tony Scarborough to carry out appropriate cutting as was done last year.
- c) It had been noted that a local resident Mr John Taylor had been carrying out grass and hedge trimming along Rice Lane. The Chair had thanked him for this voluntary work which he said he enjoyed doing. It was agreed that a one-off grant of £60 should be awarded to him towards his fuel expenses in carrying out this work.

**16/106 USE OF THE COMMUNITY INFRASTRUCTURE LEVY (CIL) PAYMENT OF
£5,197.50**

No ideas for this had been received from the public at the Parish Assembly. The Chair had passed on a play equipment brochure to local parents with a view to the possible purchase of swings for the Play Area. Cllr Topliss would look into the possibility of purchasing a speeding matrix sign.

16/107 HAMBLETON DC PLANNING APPLICATIONS FOR CONSIDERATION

17/01062/out - outline application for development of 4 residential dwellings on land to the north west of Foxholme House, Flawith

Following consultation with local residents in Flawith, the Aldwark Area Parish Council had formally objected to this application for the following reasons:

Whilst there have been some changes to the layout, siting and access arrangements to this proposed development from the previously refused application, the reasons for the previous refusal appear not to have been addressed, namely issues around Sustainable Development; Settlement Hierarchy; Protection/Enhancement of Natural Assets; Protecting Amenity; Outside Development Limits; Form & Character of Settlements (Protection of Intrinsic qualities of open areas); and Protection of Character & Appearance of Countryside. The principal concern remains that of the overbearing impact of the proposed dwellings on the properties opposite and this application fails to address this issue.

Now **granted** by HDC.

17/01031/MRC - Application for Variation of Condition 2 (alterations to roof height and pitch) to previously approved application 16/02094/FUL- Proposed construction of an agricultural livestock and storage building - Land To East Of Lodge Farm And West Of Drovers Lodge Flawith North Yorkshire

No objections – Now **granted** by HDC

17/01163/FUL - Proposed ground floor kitchen extension, first floor dormer roof, partial existing roof raise and detached garage - Holly Cottage Flawith North Yorkshire YO61 1SF

Following consultation with local residents in Flawith, the Aldwark Area Parish Council is neutral in respect of this application. Concerns have been expressed about the potential overlooking and loss of amenity to the adjoining property particularly from the proposed dormer roof windows and as such this part of the application may have an adverse impact.

17/00870/FUL Extension to existing agricultural storage building - Youlton Hall Hag Lane Youlton North Yorkshire YO61 1QL

No objections - Now **granted** by HDC

17/01420/FUL Single storey oak-framed outbuilding - Gillan House Flawith North Yorkshire YO61 1SF

No objections.

17/00383/FUL Amended plans: Construction of a dwelling – The Cottage, Flawith, North Yorkshire YO61 1SF

Despite the Parish Council not being alerted to the submission of amended plans or invited to comment, the Flawith parish councillor has consulted with residents of Flawith in respect of this application and in particular the adjoining residents. There continues to be unanimous support for the redevelopment of the site of this derelict property although there are concerns about particular aspects of the proposals as follows:

- i) The revised plans show full height glazing to the rear elevation and consequently there are some concerns about overlooking of the rear garden of The Firs.
- ii) A number of upper floor windows have been incorporated into the amended plans on the southern side elevation will have a direct view into the neighbouring property (Rivendell Cottage). These either need to be removed or the glazing should be opaque or frosted.

- iii) The treatment of the front elevation (view from the road) is poor and a better architectural treatment should be sought.
- iv) It appears that the eastern and northern walls of the existing structure of the derelict cottage are to be retained to a reduced height as boundary walls to the site. The existing walls will require significant repair if they are to be retained and this should form a condition to any consent.
- v) The amended plans now do not incorporate a garage or indicate any parking provision. Any consent should be conditioned so that details of parking and garaging are provided.

There are continuing concerns about the applicant's lack of any real intention to redevelop this site or to sell it. This is a major frustration for the entire village and Hambleton District Council should give serious consideration to exercising their compulsory purchase powers to acquire this long-derelict property.

As per the Parish Council's previous comments, the current state of the existing derelict property continues to be a major environmental nuisance and it is undoubtedly a blight on the village. The adjacent property owners continue to directly suffer as a consequence of the applicant's failure to do anything with the property.

The condition of the derelict property continues to deteriorate and it is only a matter of time before more of the remaining structure falls down. Whilst much of the overgrown site vegetation has been cut back, there are significant amounts of waste building materials on the site which continues to pose an environmental and amenity nuisance for the neighbours. As a consequence Hambleton District Council should look to impose a s215 Notice under the Town & Country Planning Act to force the owner to take proper action to both tidy the site and then keep it properly maintained.

In conclusion, whilst the redevelopment of the property is welcomed some revision to the proposals should be considered to mitigate against overlooking concerns and the possible improvement of the design and architectural treatment of the front elevation.

- a) Cllr Sowray reported the appointment of a new Head of Children's Services and a new Chairman of NYCC.
- b) He reminded the PC that the Locality Fund was again open for bids.

The Chair thanked him for attending the meeting.

16/112 REPORT FROM THE DISTRICT COUNCILLOR

- a) Cllr Knapton reported that 51% of Hambleton households had signed up for Green Bin licences.
- b) The District Council was carrying out an anti fly-tipping campaign.
- c) The new HDC Local Plan would go to Cabinet in December.
- d) The contractor for Phase 3 of the Superfast Broadband Roll Out would now be decided in October. The Chair reminded him that many households within the 3 Aldwark Area parishes were without a satisfactory broadband speed. Cllr Knapton encouraged him to join with neighbouring parishes to place pressure on the new contractor to improve reception for all our households.

The Chair thanked him for attending the meeting.
